

## Sheridan Fire District Meeting Minutes

The Sheridan Community Fire Protection District Board of Trustees met on Thursday October 2<sup>nd</sup>, 2025, with the following present: Debra Augsburg, Paul Brennan, Eric Wormley, Chief Tirevold and Attorney Mike Fuller.

Meeting was called to order at 7 pm by President Augsburg. Minutes of the September meeting were read and approved with no additions or corrections. Brennan motioned to accept the minutes as presented, Wormley 2<sup>nd</sup> the motion.

Bills were presented and discussed. Wormley motioned to pay the bills, Brennan 2<sup>nd</sup> the motion.

Treasurers report discussed. Chief Tirevold stated he at Attorney Burton met with Gabriella from Weber & Associates to discuss the audit and balances. Chief Tirevold presented the new Treasurers Report format and explained how all the figures come together to match the auditors' figures. These reports will be for the calendar month not meeting to meeting dates as far as balances show. Chief worked on formatting the new reports to make all the District and Auditor have the same information at the end of the FY. Brennan motioned to accept the Treasurers report, Wormley 2<sup>nd</sup> the motion. Chief presented the transfers needed to be made to make the fund balances equal to what is in the Illinois Funds Account. Discussion held on the transfers, Brennan motioned to transfer \$100,000.00 to the Ambulance Reserve Fund from the Ambulance Fund, Wormely 2<sup>nd</sup> the motion. Funds to get transferred.

Chief stated the department responded to 36 ambulance calls and 4 fire calls in September. The Department is about 80 calls down from 2024 at this time.

Safety Report, kids in school and farming season with farm equipment injuries and traffic.

Chain saws were taken in for repair.

All paperwork has been sent in for the DNR Grant, the District should be getting a check soon. All landing zone LED flashing lights and orange traffic cones have been received. Duty T shirts and sweatshirts have been received.

Asst Chief Cook has lined up the school for Fire Prevention week on Wednesday October 8<sup>th</sup>. The OSFM Small Equipment Grant is open, Chief Tirevold will be putting in for some equipment again. Chief Explained the deck gun on Engine 812 broke, the new one from the Equipment Trailer had to be put on the Engine. Chief stated he then had to order one for the new engine due to the fact the one intended for the engine is now in use. JD Doors was up to replace a broken spring on the South End Door. Chief ordered 2 spare springs, so we have them on hand and won't have to wait for them if another one breaks. Chief discussed the FOIA request from California, Chief has been in contact with Rich Burton on the and the Data Center who sent. Its requesting records from 2021 to present. Chief stated he should have this completed by 11/1/2025. The Audit paperwork for ARPA Funds received in 2023 and 2024 has been sent in, waiting on final word if any other paperwork is needed. Attorney Fuller presented information on the Tax Levy Consideration of 105% Public Hearing. Board approved the hearing. Attorney Fuller and Burton to work on getting this set up
